- Introduction of the EU-NAO's Office Staff and Office
- 10th EDF = EUR 7,488,000.00

Start: 25/03/2013 End: 25/03/2019

• 11th EDF = EUR 11,990,000.00

Start: 11/05/2016 End: 11/05/2022

- Budget Support = Eur 10mill
- Multi Annual Programme Estimate (Energy Bill TA) = Eur 1.1mill
- B-Envelope TC Gita NNUP Area 3 approx. Eur 2mill
- Total Financial Contribution = approx. Eur 20 mill

Evaluation of the Budget Support and Way Forward



- Evaluation of Budget Support: EU is looking to conduct this for the 10th & 11th EDF for best practices.
- Forward thinking: Post Cotonou Agreement
 (Neighbourhood, Development and International Cooperation Instrument NDICI instead of European Development Fund EDF)
- Tonga's Priority for the next EU Agreement: Focal sector = Energy.
- Tonga's proposed Non focal areas= Education & Border Management but available facility is not confirmed yet by EU.

EU Funding Commitment

- NDICI 2021-2027: Focal Sector in Tonga is Renewable Energy
- EU commitment is for the implementation of the Energy Bill.
- Implementation in 2 phase:
- 1. 2021-2024 = Eur 10 Mill
- 2. 2025-2027 = will determine according to target met.
- Decider= Approval of the Energy Bill 2021 & TERM Plus with a M&E Framework
