The American Samoa Government (ASG) issues a Request for Expression of Interest (RFEI) from qualified, responsible firms to serve as:

***"Terminal Operator of the American Samoa Government Fuel Facilities"***

The American Samoa Government owns the Fuel Facilities which are located on the Island of Tutuila, Territory of American Samoa. The Terminal Operator operates these facilities under a Permit and Agreement (P&A) contract with the American Samoa Government.

The Terminal Operator is responsible for the day-to-day operations of the Facilities, and also functions as the supply manager of requisite petroleum products, such as diesel, unleaded motor gasoline and jet/kerosene.
